
OPEN SPACE SURVEY RESULT REPORT

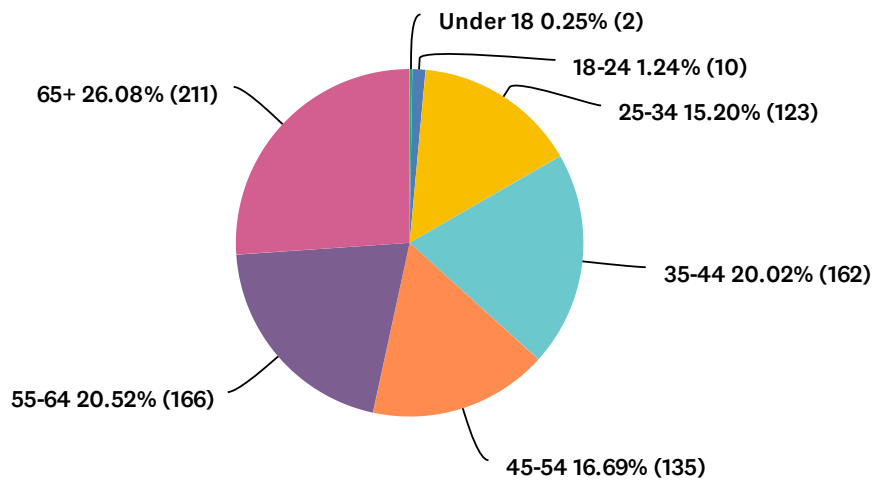
Hilco Redevelopment Partners (HRP) launched a public survey to gather community input on the open space features planned for the redevelopment of the former Potomac River Generating Station power plant site in Old Town North. The survey was released in May 2023 and shared widely throughout Alexandria. It was available in five languages, and 816 community members responded.

An overwhelming number of local residents listed walking, jogging or biking as their primary reasons for visiting the project's open space. These priorities are reflected in the community's main programming requests, which include walks and trails, overlooks and flexible lawns, waterfront access and seating, and accommodations for active recreation such as biking, boating, fitness training and pickleball. Over 87% of residents are in favor of a personal watercraft launch and nearly 74% are looking forward to the adaptive reuse of the pump house that will bring waterfront dining, expanded waterfront views, and replacement of "the cage" at the Mount Vernon Trail. Sitting in a shaded area or enjoying programming such as farmers markets and art fairs rank high for over 50% of residents, while those who plan to visit for passive recreation are in favor of walking trails (89%), pollinator gardens (71%), and native planning gardens (68%). Natural elements ranked high across the board, including those visiting with children and dogs.

The valuable feedback from Alexandria residents received via the survey informed the evolution of the nearly 14 acres of new and improved open space planned for the redevelopment of the former power plant site.

Q1 What is your age?

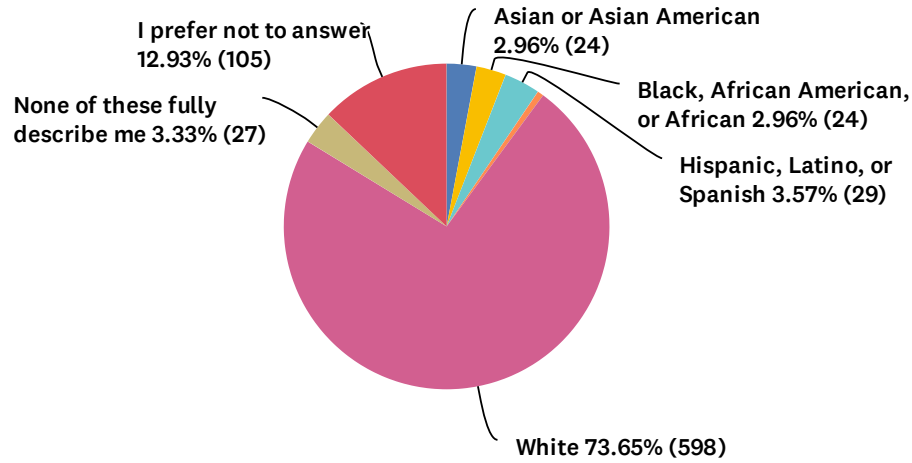

Q2 What category best describes you?

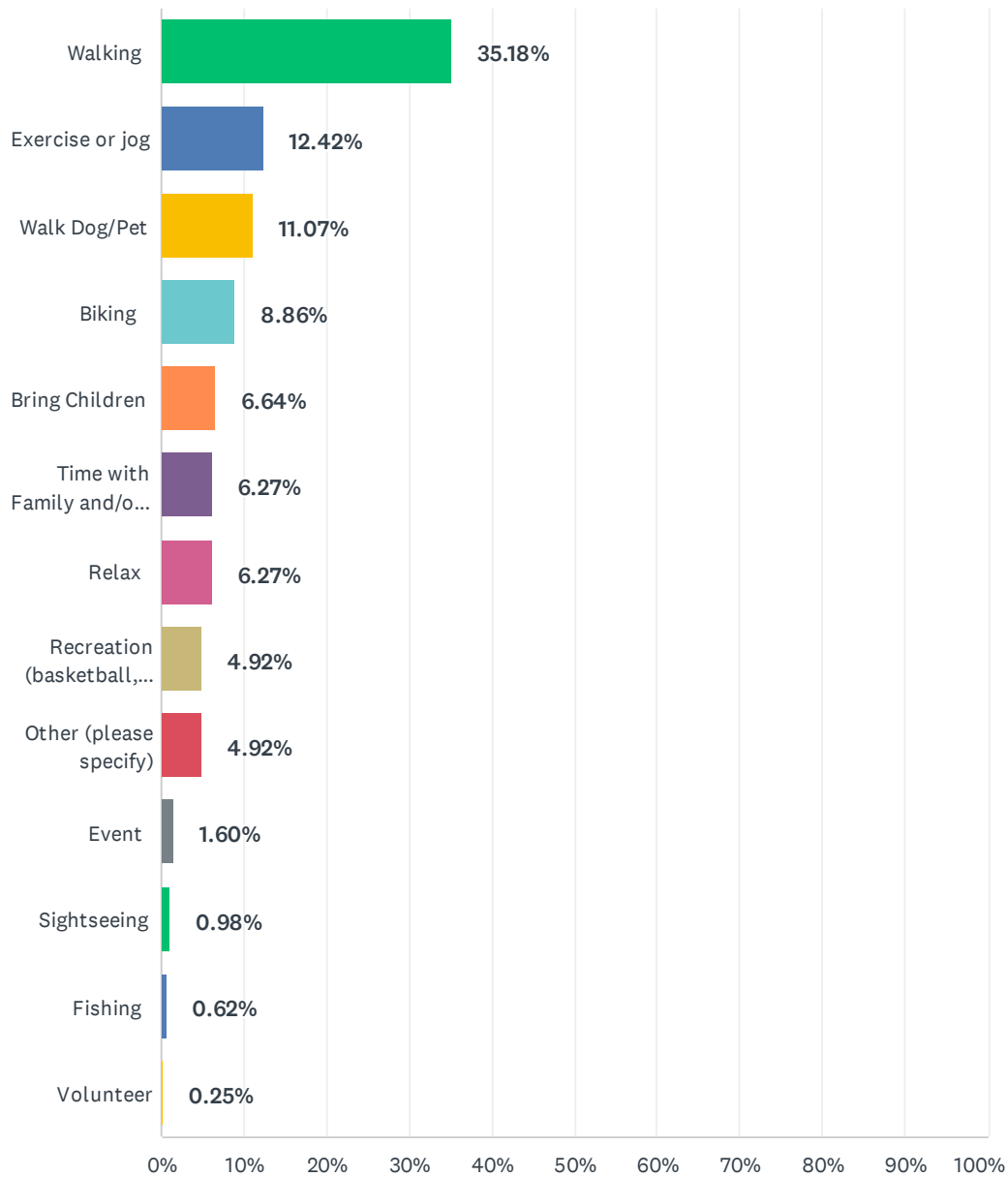

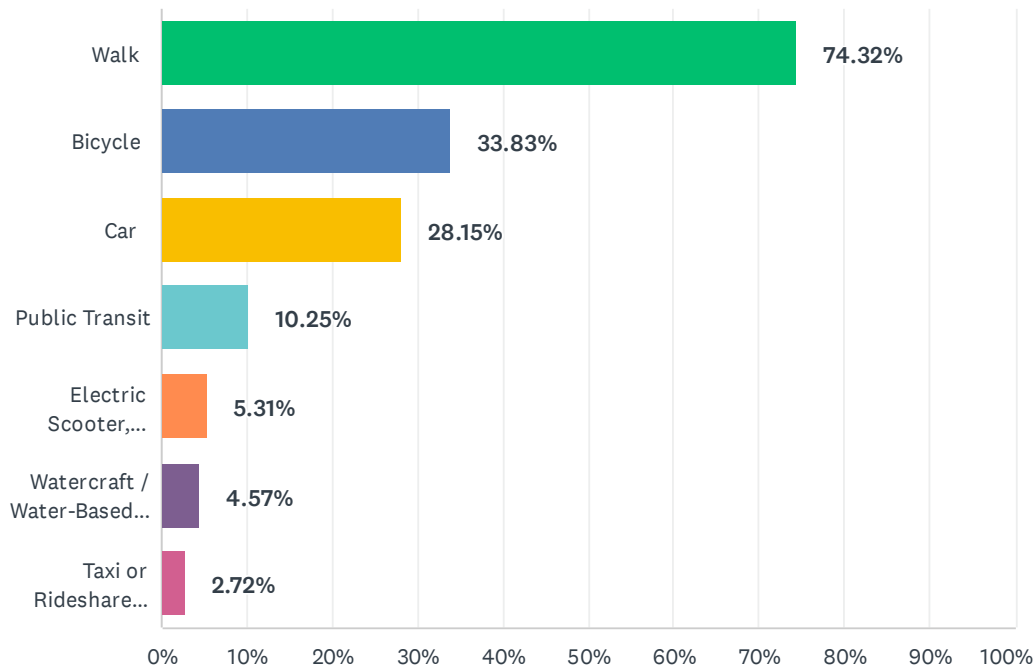

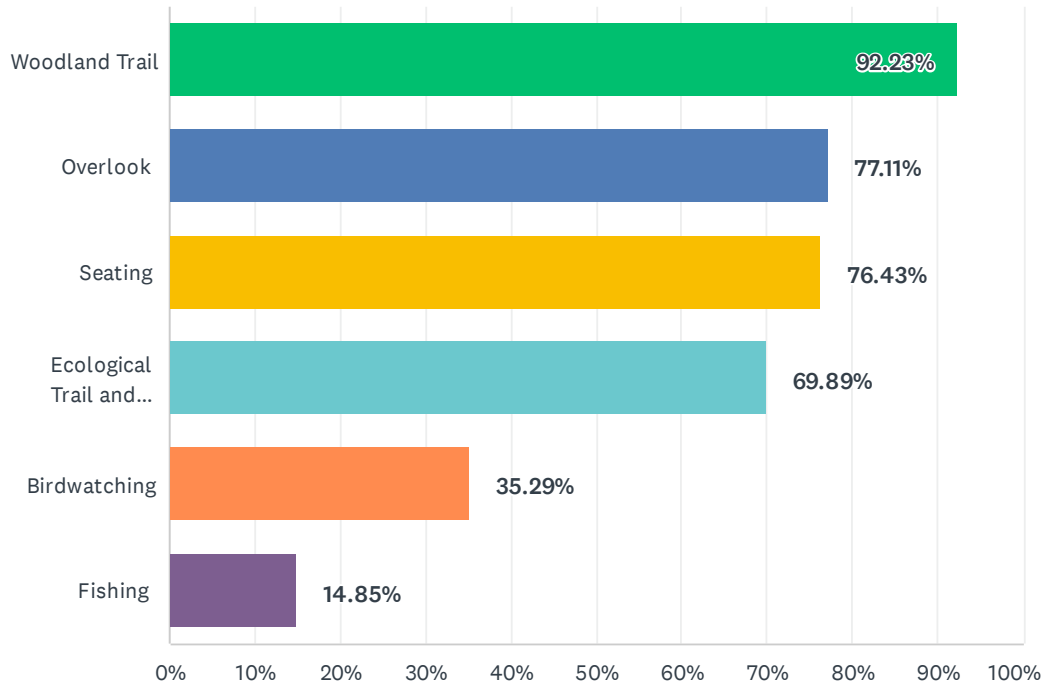

Q5 Passive Waterfront Area:(Click on all that will interest you and your household.)

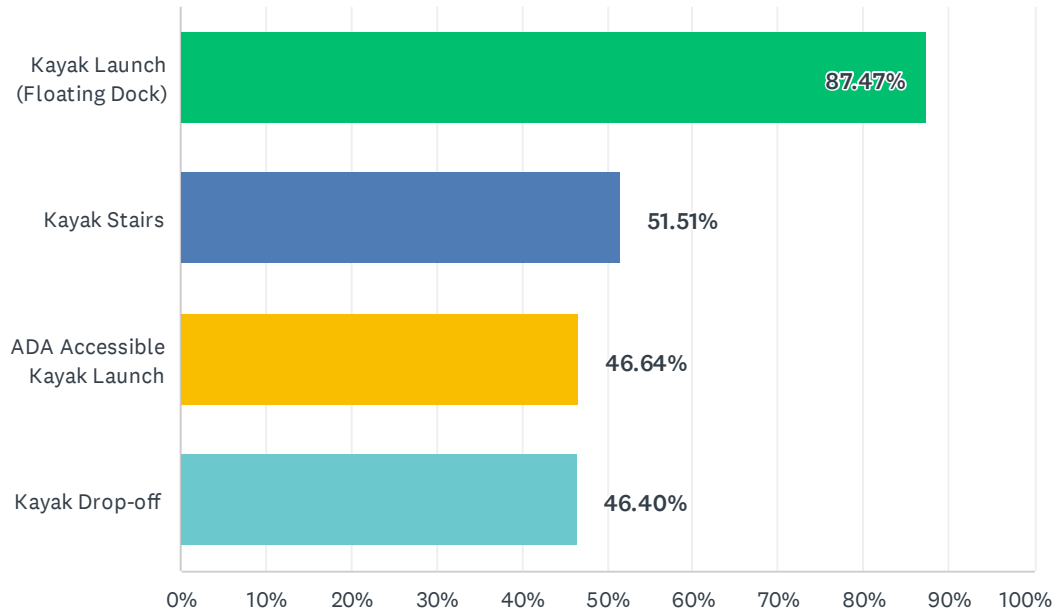

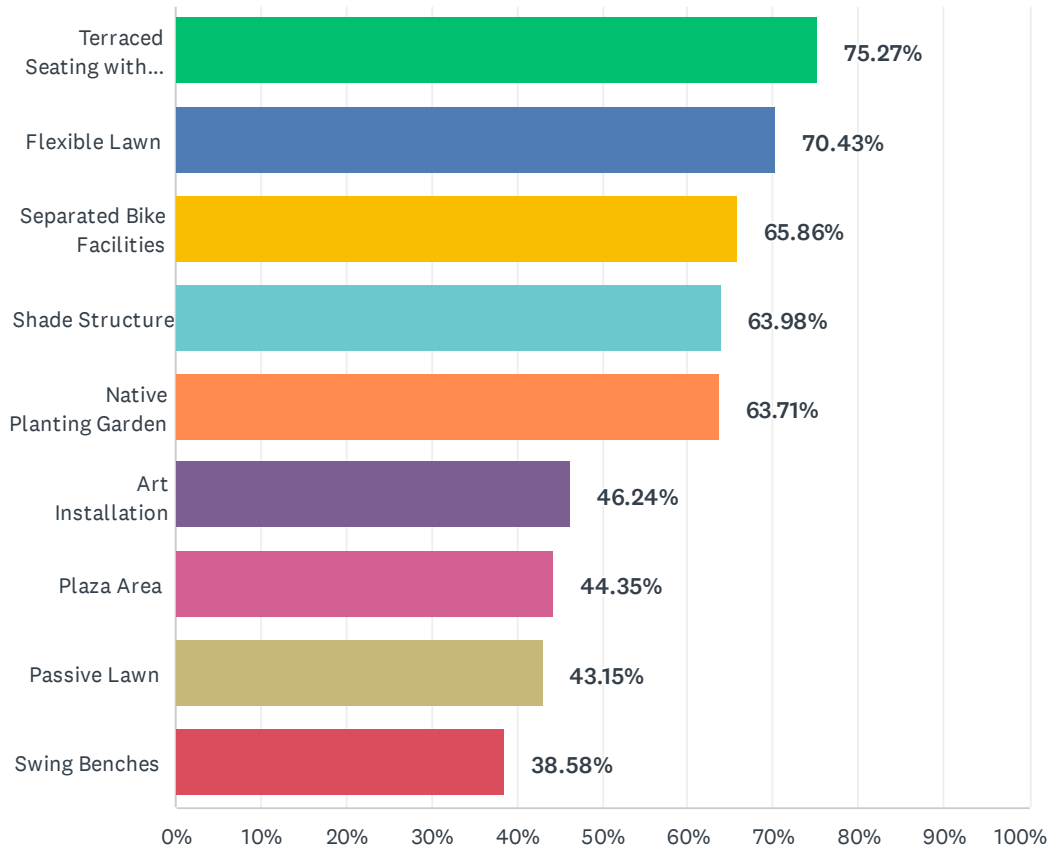

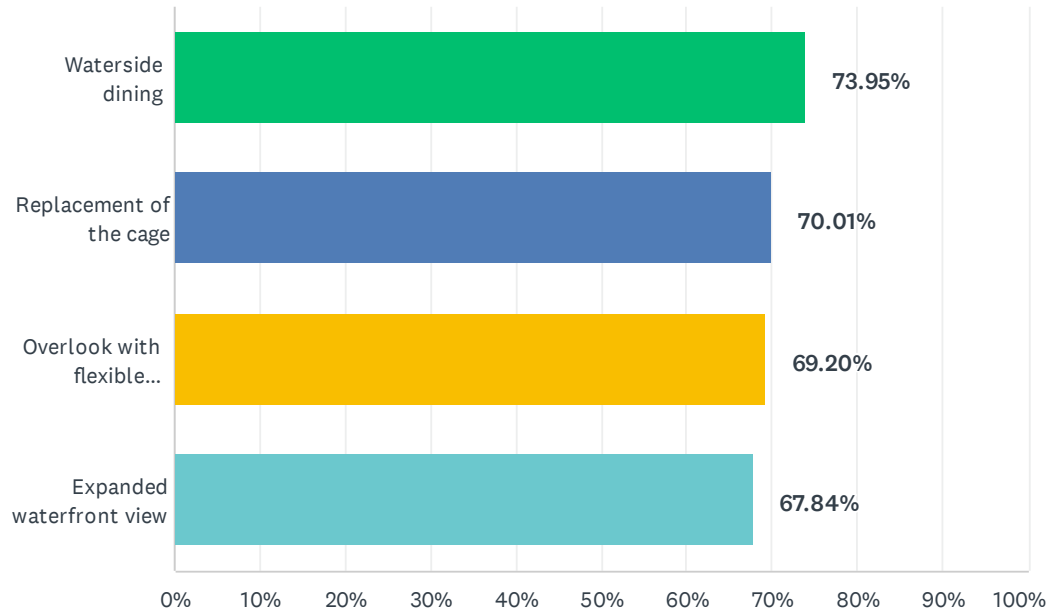

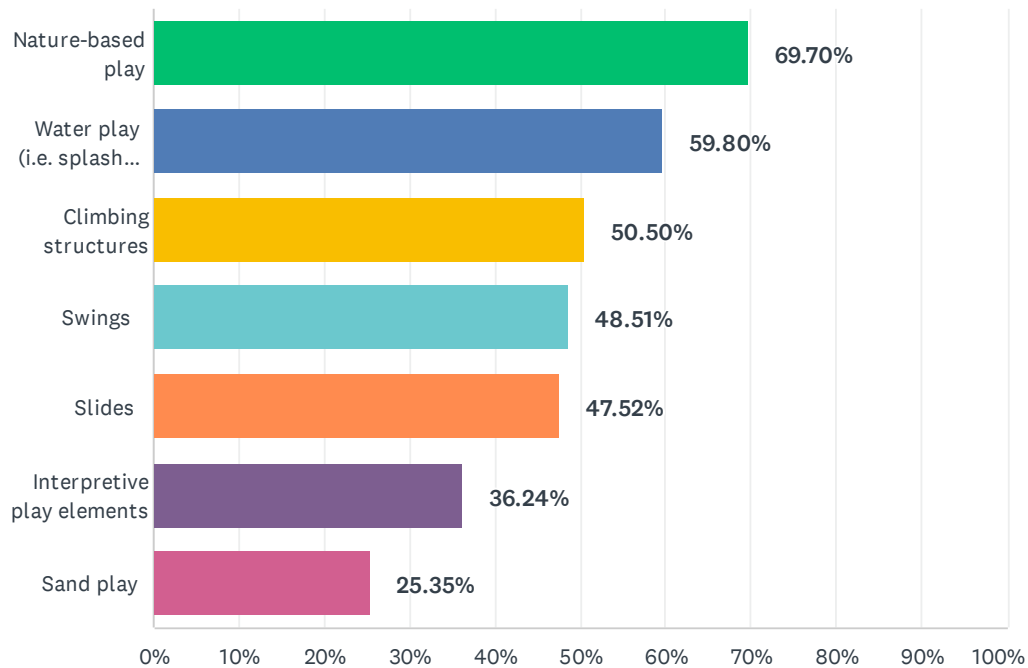

Q11 Kids Play Area:(Click on all that will interest you and your household.)

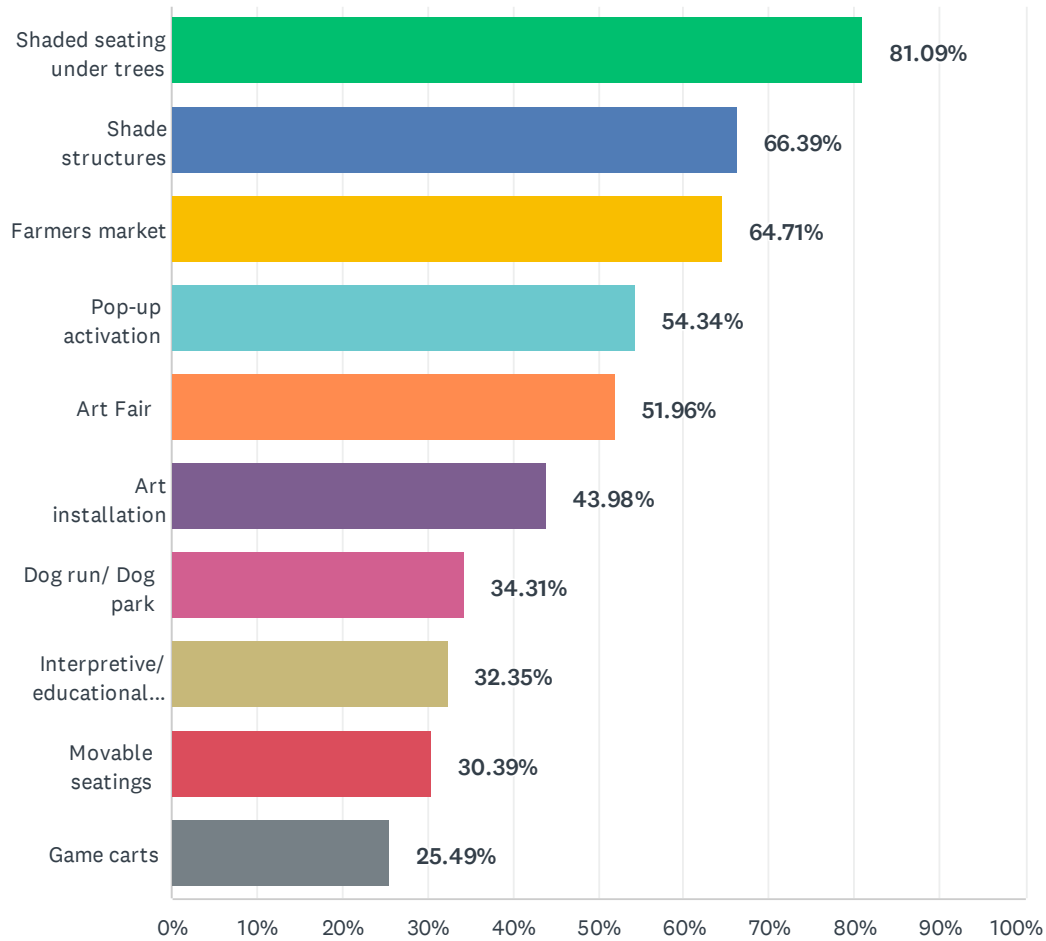

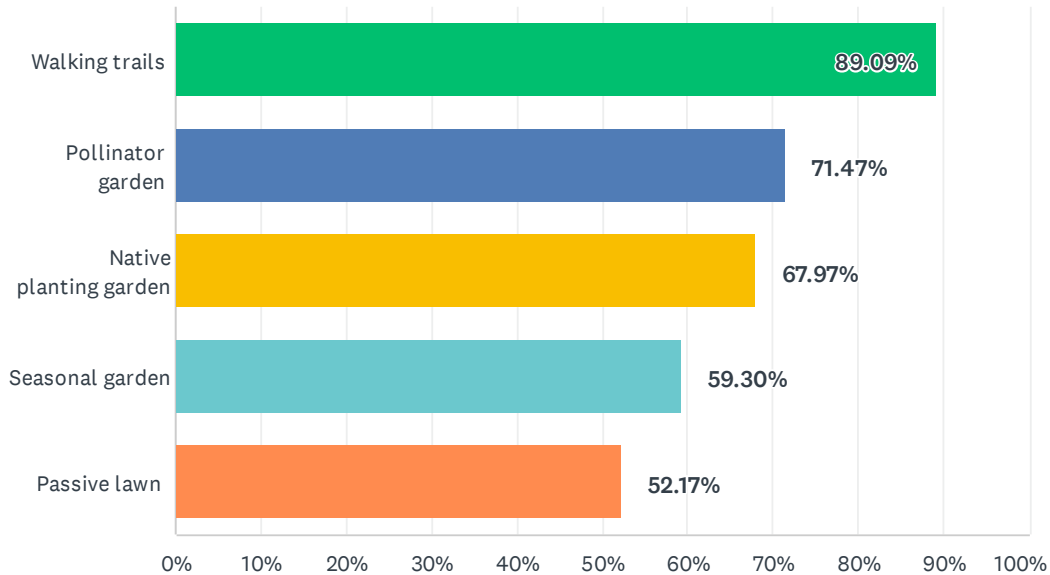

Q13 Passive Landscape Zones:(Click on all that will interest you and your household.)

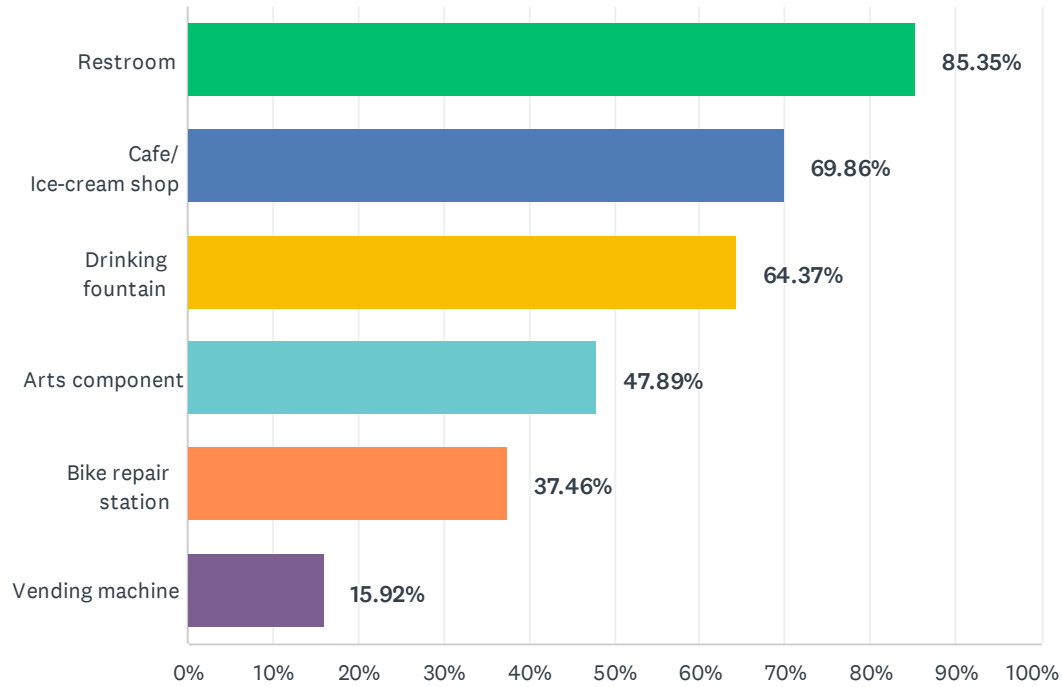

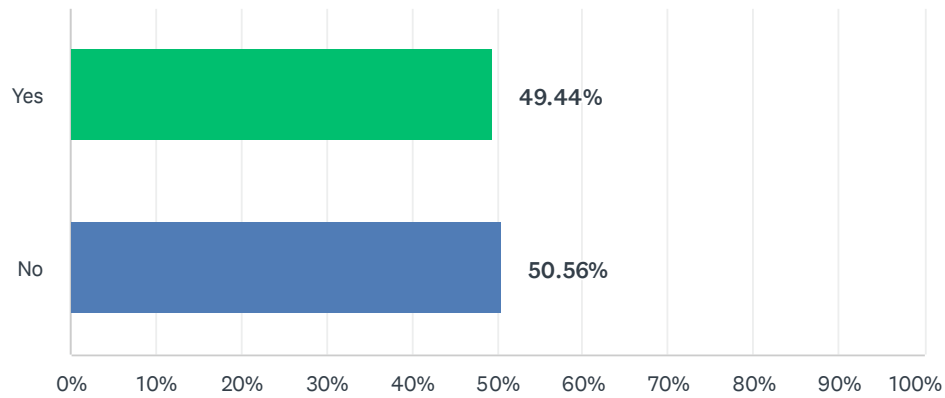
